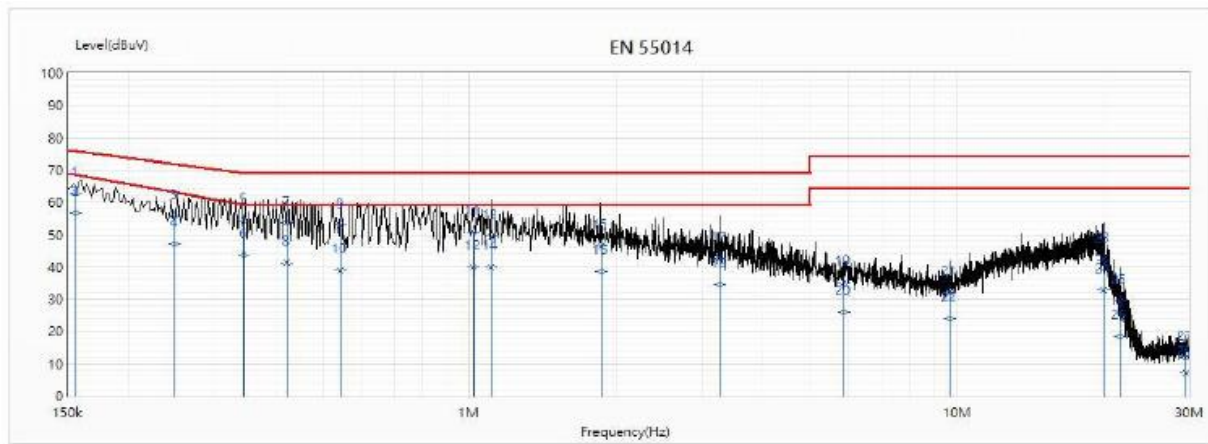

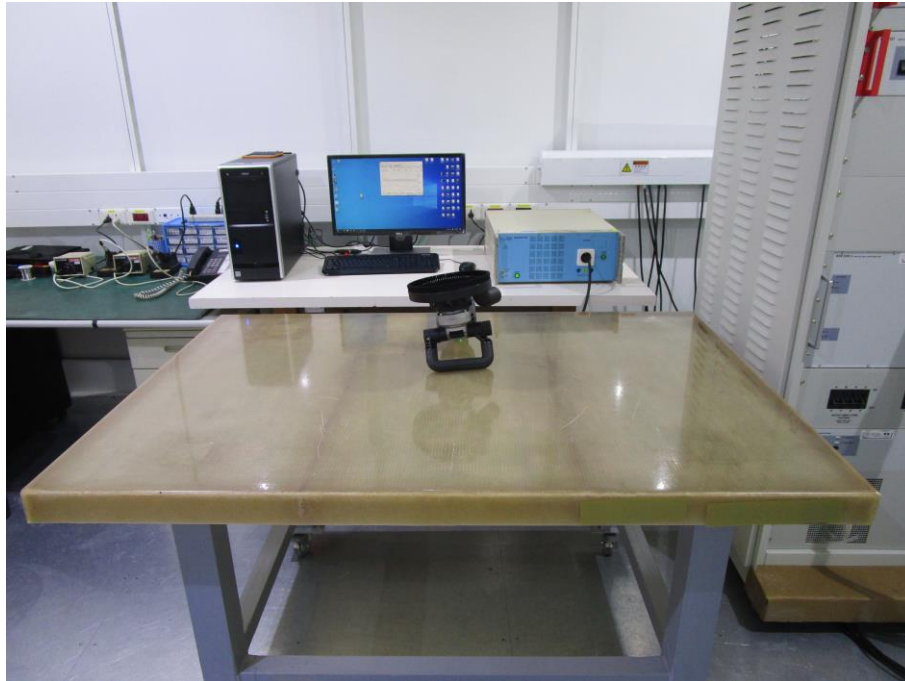
### Conducted disturbance voltage at mains terminals



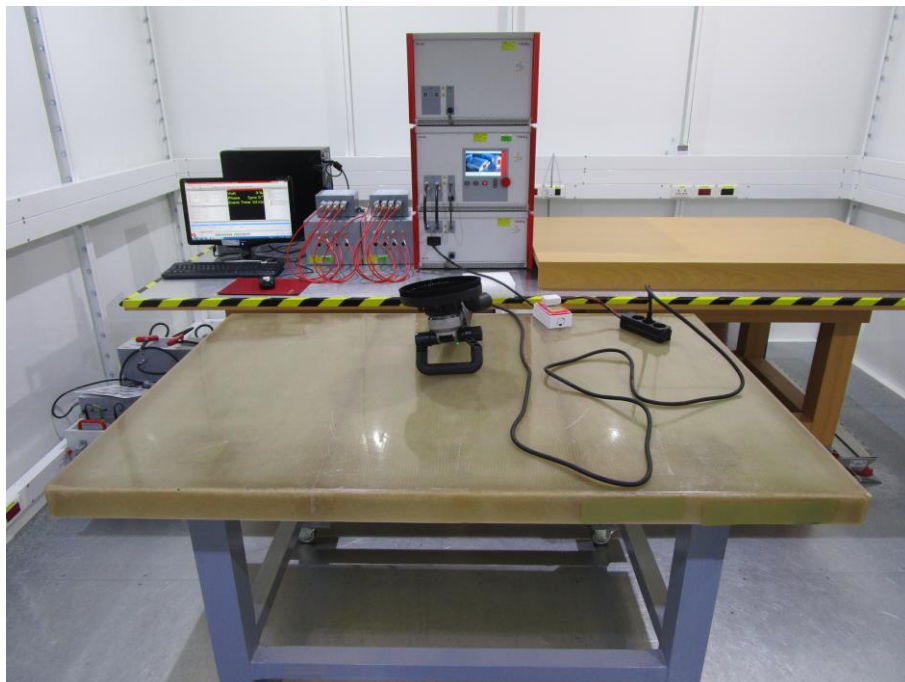
### Disturbance power



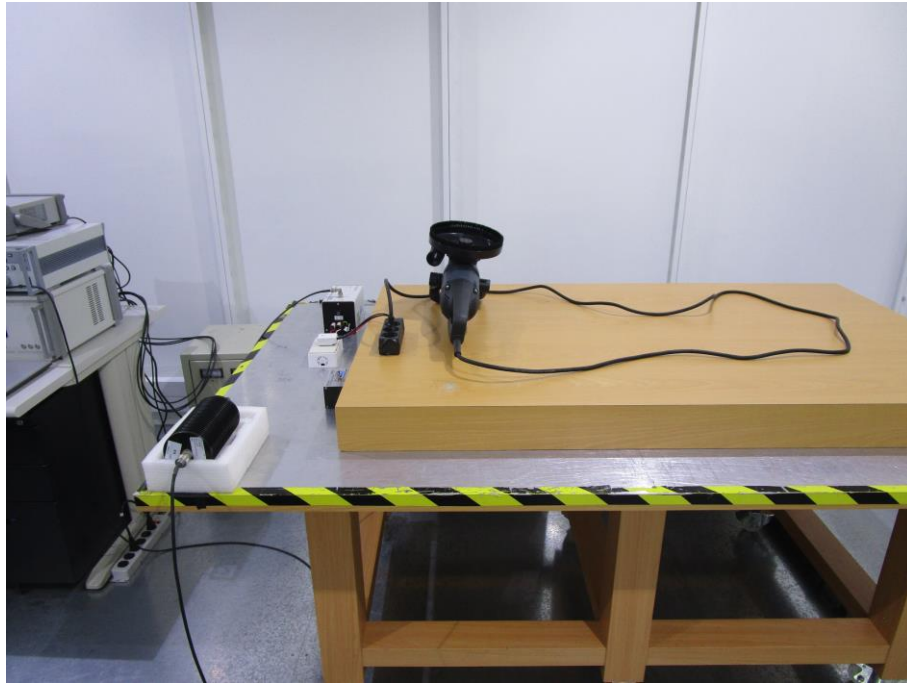

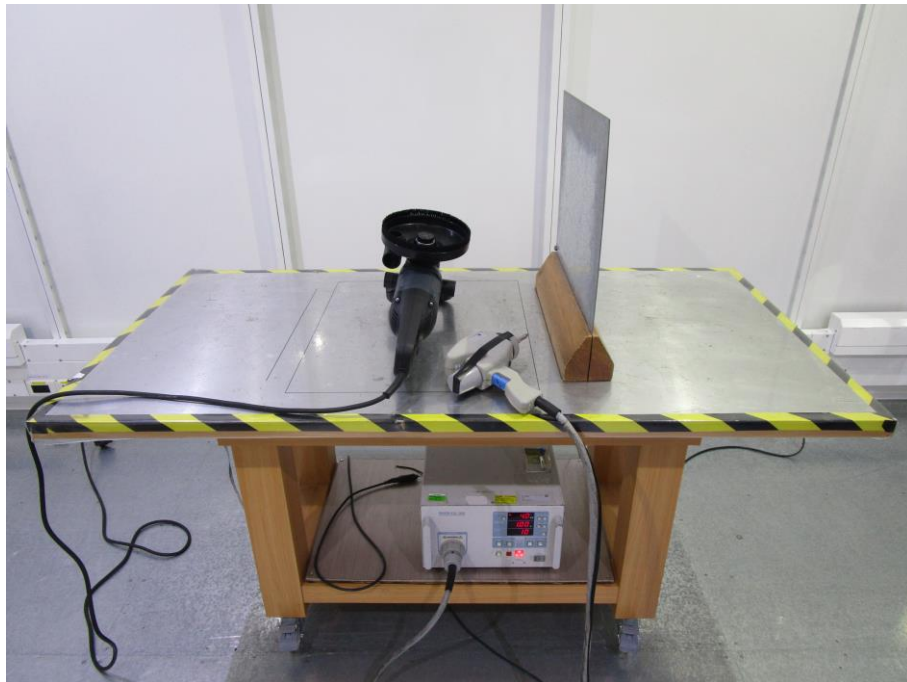
